
Build an inventory of relevant regulations, importing available policies, requirements, and controls from UCF and keep them up to date.

Collaborate with application owners to assess compliance with regulatory and security requirements. Assess risks with risk owners and consolidate assessment results per business line and regulation/policy.


Remediate compliance issues


Central Repository

- Manage controls across multiple IT regulations based on the industry-leading UCF framework.




Contextualize regulations with IT Assets

- Prioritize compliance initiatives and remediation plans based on IT assets criticality.








United Compliance Framework (UCF)

The UCF framework is the largest library of interconnected compliance documents that map and harmonizes more than 10,000+ IT control statements to more than 1,000+ regulations, standards, and frameworks. The UCF library contains a large number of authority documents across many industries and regulations, including Sarbanes-Oxley, PCI, HIPAA, NIST, ISO 27001, COBIT, and many more.



Furthermore, UCF identifies controls which are common to multiple applicable regulatory documents, thus helping companies avoiding duplication of efforts and reducing time and cost of compliance.



Data import

HOPEX offers out-of-the-box integration with UCF to accelerate your IT compliance management. During data import, the user will select the set of regulations it must comply with and the applicable IT controls.



Automatic mapping of regulatory content to HOPEX entities

Once the data imported into HOPEX, all the regulations, citations, controls are automatically mapped to HOPEX entities with appropriate naming and IDs. Companies can then further analyze and deploy their compliance initiatives.
